- In terms of a civil case update, I wish to thank Judge Nealon, Judge Gibbons, Judge Mazzoni, Mauri Kelly, and Tim Hinton for the extraordinary work they have done this past year reducing the number of inactive civil cases greater than 24 months old. At the direction of the AOPC, an age-of-inventory benchmark was set requiring no more than 25% of all civil actions to be pending for more than 24 months. At the start of the project, 43.70% of our civil action inventory was pending for more than 24 months. Their work resulted in 1,697 civil actions closed and our year-end statistics show that only 21.57% of our pending civil action inventory is now pending for more than 24 months. Great job by Judge Nealon and his team.

• I want to update you on plans for renovations at the main Courthouse. We are working with the County to remodel the lower level of the Courthouse which previously housed Central Court and the Processing Center. Our plans include the relocation of the Court Administrator's Office and the Jury Assembly Room from its current location on the first floor to space on the ground floor. This will free up much-needed space for the expansion of both the Clerk of Judicial Records Office and the Public Defender's Office. Also, new space will be allocated for the law library and meeting rooms for attorneys and clients to meet prior to court hearings.

We recently purchased wooden benches from a church that was closing in Pike County and have placed them on the second and third floors of the main Courthouse. This is part of my plan to improve the aesthetics of the Courthouse, with the next phase to include artwork of local historical significance.

Another important project we are working on in conjunction with the County and the Office of Youth and Family Services is the establishment of a wing at the County Prison dedicated to housing juvenile offenders. This will allow for Lackawanna County juvenile offenders to be housed locally during their detention status. • I wish to thank the Bar Association and in particular, Lee Ann Munley, her staff, and the officers and directors for all their great work throughout the year. We enjoy a wonderful relationship with the Bar Association and are grateful to all of you.






